### **PROGRAMS**

### THE REGIONAL ATTENDANCE COOPERATIVE

"to improve student attendance and prevent dropouts . . ."

The Regional Attendance Cooperative (RAC) is part of a statewide effort to improve student attendance and prevent dropouts. RAC serves Boone and Winnebago Counties excluding Rockford District #205 and works with students, families, schools and community agencies to promote student success and prevent youth from dropping out of school. RAC also provides technical support to facilitate school-based projects designed to enhance student success.

During FY2019, the RAC served 347 truant and chronic students and families with 249 students (71.7%) achieving 90% attendance rate after intervention and 291 (83.7%) improving attendance to allow them to be promoted to the next grade level.

### THE REGIONAL LEARNING ACADEMY

"to assist an effective transfer back to a regular educational program . . ." The Regional Learning Academy is the Regional Safe Schools Program for Boone and Winnebago Counties. RLA serves students who are habitually disruptive or have been recommended to the program by a served district. The program works with students who are younger than 18 and in grades 6-12.

Students are instructed by teachers experienced in multiple curriculum contents including Mathematics, Science, Social Studies, Physical Education, Health, English and Business Technology. Enrollment is based on funding levels from the state and can vary from year to year.

The program addresses the academic needs as well as the social emotional needs through Individual Learning Plans. The goal of the program is to assist students in making an effective transfer back to a regular educational setting or another alternative program so that the student can reach their particular educational goals.

## STAR-WINNEBAGO and STAR-BOONE

THE REGIONAL LEARNING CENTER

"educational options for young people 16 to 21" The Regional Learning Center provides educational options for students who are 16 to 21 years old who have left school prior to graduation. The site locations are at STAR Winnebago and STAR Boone. The programs offer full-time academic classes via online learning and instructor led classes.

The Regional Learning Center offers a multi-disciplinary curriculum that a student can use toward graduation or High School Equivalency testing. Academic skill building is offered throughout the programs that allows students to progress at their pace toward successful completion of the program. In addition, the program works with students on job seeking skills, resume building, academic counseling, truancy intervention, and drug/alcohol recovery support. Enrollment is based on funding levels from the state and can vary from year to year.

### **PROGRAMS**

CEANCI works with school districts to create access, alignment, efficiency and partnerships for high school students in Career and Technical Education programs. It's an exciting time to be in this education field, as CTE moves to play a vital role in helping American business close the skills gap by building a competitive workforce for the 21st Century.

CEANCI supports over 100 CTE instructors at the 14 high schools in the Boone, Winnebago and Ogle County region — ultimately impacting over 14,000 high school students in any given year. The grants that we administer enable us to provide state of the art technology and equipment, curriculum and materials. We offer opportunities for students to earn industry credentials, access to business partners, professional development for instructors and career exploration experience for students.

PROGRAMS

### THE REGIONAL **ALTERNATIVE SCHOOL**

The Regional Alternative School operates at four sites throughout Boone and Winnebago Counties. Our membership districts include Belvidere, Harlem, Hononegah, Pecatonica, North Boone, Rockford, South Beloit, and Winnebago.

The program provides an alternative environment where our students progress toward their goals for college and career success. Instructional practices blend online learning and instructor lead classes, to support the students' academic pursuits. Our programs offer academic assistance, job seeking skills, resume building, graduation and career planning, truancy interventions, socio-emotional interventions as well as substance abuse counseling.

Program hours are Monday through Thursday 2:30-7:30 and Friday 2:30-5:30.

### High School Equivalency. . . . (General Educational **Development)**

The Regional Office of Education administers the High School Equivalency tests and issues the Illinois State High School Equivalency Certificate. Applicants must be 17 years of age or older, a resident of the state and show proof of eligibility. Brochures and further information are available upon request from our office.

### Fingerprint Based Criminal History Record Checks

Live Scan fingerprints are conducted on all public and private school personnel including contractors who are being employed by the Boone and Winnebago school districts. Both State and FBI databases are included. The Illinois Sex Offender and Violent Offender Against Youth websites are checked that an applicant is not on the list. The check must be initiated prior to commencing employment. Reports are sent electronically to the school district. ROE also fingerprints for Illinois Department of Public Health workers, and some licensing and Illinois gaming locations. ROE is a vendor for FIRM Systems. A total of 2249 fingerprints were completed. The following is an itemization of the fingerprints implemented.

## The Regional Office of Education serves as a liaison between Illinois State Board of Education evaluators, applicants, and Human Resource Departments of the school districts within Boone and Winnebago counties.

Illinois state law requires all educators to hold valid registered licenses and meet all qualifications in administrative and instructional areas. Educators must register and renew their licenses on-line in accordance with renewal dates.

In addition to providing technical support, the Regional Office of Education maintains substitute and teacher vacancy lists. Counseling is offered to educators to evaluate transcripts to determine courses needed to teach additional subjects. This evaluation is unofficial and does not constitute official approval from Illinois State Board of Education.

## The Regional Office of Education is a sub-grant holder for the McKinney-Vento Homeless Student grant for the Boone and Winnebago counties area. During FY2019, 3,140 students were identified by their school districts as homeless under the provisions of the Act. This is a lower number than past years because students awaiting DCFS placement no longer qualify as being homeless. This resulted in an increase of 357% since FY2011.

The Regional Office of Education provides training opportunities for district liaisons, guidance when questions arise and verifies compliance with the Homeless Act.

### **SERVICES and STAFF DEVELOPMENT**

Workshops, conferences, and seminars are conducted for educators, as well as the community, in response to needs identified by individual districts, the region, or as a result of new state mandates affecting schools.

### DISTRICT SUPERINTENDENT MEETINGS

Superintendents meet six times a year to discuss current issues of mutual interest and concern. These meetings provide for the dissemination of information, technical assistance and clarification of mandates from the Illinois State Board of Education representatives or the legislature. They provide a forum for an exchange of successful administrative practices.

### HEALTH/LIFE SAFETY INSPECTIONS

Each of the public schools and school related buildings in the Boone-Winnebago Region is inspected annually to assure compliance with the Health/Life Safety Code Sec. 180. All public schools are required to be maintained in continual compliance with the minimum standards according to school code. The record of the annual inspection is sent to the president of the local district school board and a summary is filed annually with the State Board of Education as required by law.

Every ten years each public building must be re-surveyed for continued compliance by an architect or engineer licensed in the state of Illinois. The Safety Survey Report generated by this inspection lists any items which need to be corrected to bring the building into full and continual compliance. Funding for life/safety work may be accessed by amendment with the approval of the local school board, the Regional Superintendent, and the State Superintendent of Schools or by levy. Upon completion and inspection by the licensed professional and Regional Office staff, the building is awarded a certificate of completion or compliance.

The Regional Office of Education, through its Regional Superintendent, issues all demolition permits, construction permits, repairs permits, and occupancy permits for public schools in the region.

Records of all amendments and construction information are kept on file in the Regional Office of Education.

### REGIONAL SPELLING BEE

The 36th Annual Spelling Bee, sponsored by the Eunice Wishop Stromberg Spelling Bee Endowment Fund and the Community Foundation of Northern Illinois, was held at Harlem High School on March 19, 2019. Each of the winners from 32 public and non-public schools received a medal in an award ceremony at the beginning of the evening. The first, second, and third place regional winners received a VISA gift card and a trophy. The winner of this regional event for 5th, 6th, 7th and 8th grade students was Avani Joshi a 6th grade student from Roscoe Middle School, Roscoe, IL. The winner received a trip to Washington DC for the National Spelling Bee.

### TRUANCY ANNUAL REPORT 2018 - 2019 SCHOOL YEAR

The Regional Office of Education was responsible for the supervision of 202 educational neglect and truancy cases during the year, making a total of 707 appearances in the courts of the 17th Circuit.

The emphasis on intervention continues to shift more toward filing educational neglect petitions, which have the possibility of consequences, rather than a traditional truancy petition. The process of establishing an educational neglect case takes more time but has proven more effective. In cases where the truancy interventionist believes the student is solely the main person responsible for the lack of attendance, a truancy petition is still filed. Sometimes situations in the student's life can lead the Court to view that it is the best interest of the student to be removed from the home while the situation is addressed by the parents.

Cases are set for one Thursday morning and one Friday morning each month in Winnebago County and one Monday and Thursday afternoon in Boone County. In Winnebago County, the morning calls are at 9:00am enabling the ROE to establish a schedule to allow truancy interventionists and parents/students to minimize waiting time and meet any special scheduling needs.

The Mental Health Juvenile Justice (MHJJ) program at Rosecrance continues to be a great resource for interventionists including mental health referrals and substance abuse plans. Calls to the DCFS hotline for "Child Welfare Service" are increasing. This is an attempt to meet the service needs of students/families and avoid a referral to the court system.

We are proud to say we have a court system and community partners with Youth Services Network, the Dept of Children and Family Services, Youth Services Bureau, Catholic Charities, church Paper Angel Project, Food Pantries, Crusader Clinic and more that assist in the effort to overcome the barriers students face when not attending school.

### **NON-PUBLIC SCHOOLS**

The Regional Office of Education has no legal jurisdiction or control over private schools. Services available to non-public schools include Compensatory Education, Food and Nutrition programs, and Vocational and Technical Education. Non-public schools are offered the opportunity to participate in all federal and state funded programs and staff development. Some private and parochial school children who live on school bus routes are transported by public school busses.

The Illinois State Board of Education has established guidelines and policies for the registration and voluntary recognition of non-public elementary and secondary schools.

The Regional Board of School Trustees is elected by the voters of Boone and Winnebago Counties. Seven members serving six-year terms represent different townships of the counties. The Boone-Winnebago Counties Regional Superintendent of Schools serves as Ex-Officio Secretary of the Board.

The Regional Board of School Trustees handles detachment and annexation petitions and consolidations of school districts.

### LEGISLATIVE DEVELOPMENT OF THE OFFICE The Regional Superintendent is the direct successor to the Commis sioner of School Lands, an office that originally had nothing to do with the supervision of schools. 1829 The Sixth General Assembly made it the duty of the body known as the County Board to appoint a competent and responsible person to act as commissioner and agent for the county in the sale of public lands. 1841 The Legislature changed the title to County Commissioner, an ex-Officio County Superintendent of Schools. 1865 The Legislature called for the election of the County Superintendent of Schools. Until 1973 There were 102 County Superintendents in Illinois-one for each county. 1973 By consolidation of smaller counties into regions, that number was reduced to 78. 1977 Further consolidation of smaller counties reduced the number of regions to 57. 1994 Legislation passed that eliminated the office of the Regional Superintendent in Cook County as of June 30, 1994. Subsequent law allowed for reinstatement on August 7, 1995. 1995 The 57 ESRs were reduced to 45 and the services of the 14 ESCs were included in the largest Regional Offices of Education. 2012 Legislation passed requiring the number of Regional Offices be reduced from 44 to 35 by July 1, 2015.


